
Step 1

To complete your Got Soccer background check, go to https://home.gotsoccer.com. Click on "User Login" in the upper right-hand corner of the page. (See image below)




Step 2

Enter the "Username" and "Password" under "Individual Coach". Your login will not work under "Team Account" or "Individual Manager". (See image below)




Step 4
