## **State Farm Sports Village Rental Fees/Requirements**

### **FEES AND DEPOSITS:**

1. Field Rental: \$25 per hour/per field (two hour minimum)
2. Field Prep: \$40 per field
3. Lights: \$13 per hour/per field (two hour minimum)
4. Onsite Staff: \$15 per hour/per staff (if applicable)
5. Deposit for Cleaning and Damage: \$250.  
The deposit **may not** be refunded if additional fees are assessed for:
  - Unauthorized/extended field use beyond times listed on the permit
  - Clean-up costs to restore the facility to its original and whole condition
  - Damage or defacement to the park amenities, including equipment, grass, and foliage. In the event the damage costs exceed the amount of the deposit, the remainder of the charges will be billed to the applicant.
6. Cancellation Fee: \$30. Minus the cancellation and other non-refundable fees, a full refund will be returned if cancelled prior to 60 or more days; less than 60 days, no refund.
7. If the reservation needs to be rescheduled or changed prior to 60 days or more, there is a
8. \$20 fee. Less than 60 days, no rescheduling changes allowed.
9. The number of fields requested and tournament hours on application is what you will be charged. (If you use fewer fields or end early, no money will be refunded.)
10. No sub-renting of fields is allowed at any time.

### **SERVICES INCLUDED IN THE RESERVATION OF SOCCER FIELD:**

1. Soccer goals, nets and flags are provided at each field.
2. Facility will be lighted if the event is scheduled for night use and the appropriate fees have been paid.
3. Field prep is \$40 per field and requests are due at the time of reservation. Applicants are not allowed to prep the field in any way.

### **RESERVATION PROCEDURES:**

1. Fill out the application and submit to \_\_\_\_\_ . Upon acceptance, send the \$250 down payment (includes cleaning deposit) to \_\_\_\_\_.
2. At least 15 days prior to the event, the remaining fees must be paid in full and insurance submitted to \_\_\_\_\_.
3. At least two (2) days prior to the event, the applicant must submit a schedule covering the entire length of the reservation period. Failure to do so by the time indicated will cause the reservation to be canceled.

### **REQUIREMENTS:**

1. Rental application must be filed no less than 15 days or more than 364 days.
2. Rental application must include signature of responsible party for the event and current contact information.
3. Insurance: Certificate of Liability and Additional Insured Endorsement. Insurance certificate must have applicant's name or organization's name on it.
4. Deposit.

5. Fees as determined by how many fields are needed, lights, staff, etc.
6. Any field prep requests must be included in the application.

**INSURANCE:**

The policy shall name \_\_\_\_\_ as additional insured and hold harmless the \_\_\_\_\_ from any claims, demands, causes of action, which may be asserted, maintained, or established against the \_\_\_\_\_ and/or any of its officers, agents, employees, for death, personal injury, with limits of not less than \_\_\_\_\_ dollars occurrence. Also, and Additional Insured Endorsement is mandatory.

**RULES & REGULATIONS:**

1. Applicant may not charge an admission, request a donation for entrance, offer any items for sell or provide such items for donation or have any other concessions with written consent from \_\_\_\_\_.
2. No vehicles are permitted to drive or park upon the turf of any city park, except in designated areas. Violator's vehicles will be towed away at the owner's expense.
3. Advertising materials, flyers, or other promotional material are limited to \_\_\_\_\_ sponsored events only. No item can be posted or left without the \_\_\_\_\_'s approval.
4. The \_\_\_\_\_ is not responsible for lost or missing items.
5. The renter is responsible for all broken, damaged, missing, or stolen \_\_\_\_\_ owned equipment and/or property.
6. The following are **not permitted**:
  - Glass containers
  - Dogs off leash (Owners are responsible for proper disposal of their pet's waste.)
  - Storage of any property
  - Overnight RV parking
  - Metal cleats
7. Misuse of field, equipment, or facility shall be reason to terminate event permit and orders prompt exit of participants. If this occurs, there will be no refund of fees paid.
8. No activity will be permitted which is a violation of local, state, and federal statutes. Applicants must adhere to all \_\_\_\_\_, Bakersfield Police, and Bakersfield Fire codes during the use of the facility. Any participants violating of these rules may be asked to vacate the premises.
