Students who believe that they qualify to use a private vehicle to travel from their home to The NCLA, or other school-related destination, either as a driver or a passenger, must submit an application for a permission prior to traveling on nonschool-district transportation. In applying for permission, both the student and the student's parent or guardian must agree to abide by the following rules:

- 1. No student will be allowed to drive or ride in a private vehicle until the student's parent or guardian has submitted to the high school principal the appropriate documentation.
- 2. A passenger must submit the name of the driver with whom he proposes to ride. If a student, this driver must also have written permission issued under this Rule.
- 3. A student driver must have a valid driver's license.
- 4. Students with permits as passengers will not be allowed to drive.
- 5. Unsafe driving on school grounds is not permitted. Although The NCLA assumes no responsibility for patrolling a student's driving off school property, confirmed reports of unsafe driving will result in cancellation of this privilege.
- 6. Students will report directly to class or event and may not return to their cars until after class dismissal or said event is over.
- 7. Students may not make stops or detours when traveling between their home high schools and the event destination.
- 8. Student drivers must show evidence of liability insurance before permission is issued.
- 9. Both the student and the student's parents and guardians agree that The NCLA will not be responsible for any accidents, vandalism, or theft of property that may occur either to the vehicle or the student or passenger(s) during operation of the vehicle or on school property.
- 10. A student permitted to drive or ride must have this permission request in his/her possession whenever traveling and while at the approved destination.
- 11. The student's high school principal may revoke the permit for use of a private vehicle. Violation of these rules may also result in imposition of other disciplinary sanctions.
- 12. Students are not allowed on The NCLA campus after hours unless it is a scheduled The NCLA activity.
- 13. While the students vehicle is on The NCLA property The NCLA administration team may inspect the vehicle at any time for any reason.
