

## **Payment and Refund Policy**

Congratulations on being selected for a Greensboro United Soccer Association Travel Team!

Please read this entire document to understand the payment policies. When you accept your spot on a Greensboro United Soccer team, you are agreeing to <u>ALL</u> of the following:

- GUSA fees and Team fee payments from prior year must be paid in full before Tryouts of the next year. Tryout fee must be paid in full **prior to tryouts.**
- Filling a roster spot on a team for the entire year, June 1, 2017 to May 31, 2018.
- Purchasing and wearing the uniform kit selected by the club for the 2017-18 year.
- Making ALL payments on time for any program as specified by GUSA, including Acceptance Fee, Club Fees and Team Fees.
  - o Club Fee payments are scheduled and collected by GUSA.
  - o Team Fee payments are scheduled and collected by the Team Treasurer.
- Agreeing to pay ALL club fee payments on the automatic recurring billing cycle (if not paid in full) set up by the club upon team acceptance.
- Acceptance of a position obligates the family to pay the player's entire program fees for the year (Tryout Fee, Acceptance Fee, Club Fees and Team Fees), regardless of circumstances that may limit a player's activity or ability to play.
- If a player decides to quit the team, the family must still pay all fees, since the player has filled a roster spot.
- GUSA fees and Team fee payments from prior year must be paid in full before player can begin participating in the current season's activities.
- Failure to remit fees and/or payments on time will result in the immediate pulling of the NCYSA Member Pass (Player Card) and suspension of all player privileges including, but not limited to, tryouts, training, games and tournaments (including State Festival or Cup competition).

## **REFUND POLICY**

- Any player who accepts his position is responsible for all fees, including the tryout fee, acceptance fee, club fees
  and team fees, for the entire year. No refunds will be given at any time, unless the player suffers a season ending
  injury or if the family relocates to a geographic location making it impossible for the player to continue playing
  for GUSA. Acceptance fees are non-refundable. Injuries that cause a player to miss part of a season, but that are
  not 'season-ending' are not eligible for a refund.
- Players must fill out the Refund and Dues Relief Request form and clearly provide details about their season ending injury or relocation. Players will need to provide documentation supporting such details. Any reduction or change in club fee amount will be determined on a case by case basis. In some circumstances an administrative fee may apply. Please allow 7-10 days for GUSA's staff to review your situation.

## **NOTES:**

\*Any players that are dual rostered on teams are not expected to pay for league referee fees for their designated "second team", but are expected to pay for their share of any tournament or tournament coach reimbursement expenses to the designated "second team" if participating in an event with the "second team".
