We have the following balances in our accounts as of September 20th, 2010:

There is roughly \$3,500 in un-cleared checks for expenses recently paid. That means we have approximately \$3,500 in available funds as we end the season. This is significantly better than in recent years and is mostly due to the fact that we are not doing major construction.

Balance on the soccer club's loan as of today is \$11,018.45.

### IX. Registrar's Report:

a) Mary-Beth reported that East Central charged KSC for 22 players, when those players actually played in the Lakeshore League, not East Central. East Central should reimburse KSC \$17.50 or \$12.50 per player.

#### X. Old Business

- a) Sponsorships
  - Rodnie has been in contact with Milwaukee Wave Kilee Westrick & Greg Wilcox (Account Executives) who have expressed interest in putting up signage, at our complex. Initial cost of \$100 annual to sponsor a field was recommended. Rodnie should get proposal on sign language (e.g. Milwaukee Wave Proudly Sponsor Kiel Soccer) Meyer & Doebert fields should not be considered for advertising.
  - Additional opportunities discussed included:
    - o Advertising on back of our registration forms and website only advertising
    - A Kiel/Wave summer player camp was decided not to be in the interest of the club. However a Britt Smith expressed interest in coaches clinic.
    - o Interest was also expressed in an organized group outing to a Wave(s) game.
