The Safe Sport Act is a federal law that requires abuse awareness training (Safe Sport) for all youth sports organizations and expands existing mandated youth abuse reporting laws.
The Heads Up concussion training is required by State law.

FAQs

Q. I have already previously completed a background check for my job (teacher, law enforcement, etc.).

A. Indiana Soccer requires this to be submitted through their Gotsport system for all coaches. The background check you completed somewhere else is not transferable.

Q. I completed the background check when I coached during the 2021 season.

A. Background checks must be resubmitted every 2 years.

Q. I already did the Safe Sport training for my job or another organization.

A. If you have completed the Safe Sports training with another organization within the past 2 years, then please email me a copy of your certificate and Indiana Soccer will update your profile.
