

STEPHANIE McREYNOLDS SCHOLARSHIP APPLICATION CRITERIA



ELIGIBILITY REQUIREMENTS

To be eligible for the Crescenta Valley Little League (CVLL) Scholarship, an applicant must be an IRS eligible dependent of a current or former appointed Crescenta Valley Little League volunteer (verification required); served the league as an approved volunteer for one or more seasons; or participated in the league as a player, for one or more seasons, between ages five through fourteen.

The applicant must also be a senior in good standing, preparing to graduate from High School and attend an accredited college, university, or vocational education institution after graduation.

Recipient must enroll in a minimum of one full time class, for which academic units are awarded, during the college or university semester or quarter for which the scholarship is granted.

APPLICATION REQUIREMENTS

1. Completed Crescenta Valley Little League Scholarship Fund Application Form
2. Transcripts (photocopy of official transcripts is acceptable)
3. Copy of letter of acceptance from college, university or vocational education institution applicant will attend, or statement explaining acceptance.
4. Brief statement(s) stating educational objectives, career goals, financial need, past and current extracurricular activities (community involvement) and how this scholarship will help the applicant reach his/her goals.
5. Interviews may be required of scholarship finalists

Additionally, two letters of recommendation are recommended.

AREA OF STUDY

Any Major or course of study will be considered, however some weight will be given in the selection process to traditional courses of study and/or to educational goals that enhance the individual's career development.

SCHOLARSHIP AMOUNT

Scholarships will be awarded in the spring of each year. The number of scholarships will vary depending on the amount of scholarship funds available.

Scholarship awards will be paid within five weeks of application deadline in order to maximize the assistance provided.

Scholarship award guidelines vary from year-to-year. The CVLL board of directors establishes the size of the scholarship fund annually, while the Scholarship Committee determines the amount to be awarded to each successful applicant based on the Selection Criteria.

SCHOLARSHIP AWARDS

Scholarship awards are to be applied towards tuition, fees, books, supplies and/or equipment required for the courses at the educational institution.
