  - a. Football
    - i. BCYFL Report/Updates: First round playoff brackets have been published. BCYFL is having weekly meetings via Zoom during playoffs as brackets continue to be updated. Regular meetings will resume 11/14/22. Aliquippa only ones to charge gate fee - \$4/adult, free/kids. President of Moon resigned due to parent issues. Ellwood City/New Castle issues - came over to fence at coaching staff, being handled. Ellwood City couldn't play New Castle Mighty Mite game.
