1. Approval of Minutes from last meeting

a. Monthly Financial Report: Attached

b. Current Balance: \$116,239.02

- c. Treasurer Updates: We started out with \$105,781.93. Total income was \$26,774.38. Total expenses were \$16,317.29. Jordan Whitehead check has been deposited. Kayla will touch on Audit at the end. Submitted sales tax exemption, 3-5 weeks to get back. Will meet with CPA for taxes. We have to file tax return to keep non-profit status. Our tax return won't be due till June.

3. Committee Reports:

- a. Football
 - i. BCYFL Report/Updates:
 - 1. Any proposed by-law changes:
 - 2. Other: Tickets are done. Quip and Beaver Falls have yet to pay. They will be a 4-digit ticket, 4-\$500 winners based on the July 1st evening number. "Picnic idea" instead of the traditional coaches luncheon being proposed by Chris Trent. They will determine a field, coaches clinics for all kids of BCYFL with multiple stations set up. The head coaches would stay afterwards to receive their books. National Sports ID is open, new kids need report cards, we received word we can take report cards now and not have to wait till end of year. Quaker Valley has left the BCYFL. Still waiting for the Ironmen of North Catholic to make their pitch for membership. Hopefully a schedule will be ready to go in the next couple of weeks. Giving copies of the BCYFL bylaws that have passed. Harv from Aliquippa didn't send any notices for age change for by laws so nothing for that. By laws amendments need to be submitted October November December and will be voted on in January to try to help move issues along quicker. They are making changes to allow more flexibility and try to create more balanced schedules.

4. Open Issues

- a. 2023 Scholarships names have been given to the school & plaques have been ordered by Mr. Trophy. Mike & Jaycen will be presenting the scholarships & plaques to the recipients at the awards ceremony on Thursday, May 4th at 8am. The recipients will remain anonymous until the awards ceremony.
- b. Clearances: Reminder ALL football coaches & cheer sponsors must have clearances on file before they participate in any practices (no exceptions). Kayla will have Notary equipment at all meetings. She will also be at the cheer parent meeting to notarize clearances.
- c. CRP training when should we schedule for? Bryan Marsh's girlfriend can do it whenever. Bryan will get three dates and we will do a google form to see who is interested and when they can come. Possible schedule around heat acclimation week. Coaches and board members can do it for free and pay \$17 for card.
- d. Update on Monaca Firehall- Eddie talked to Monaca leaders including Dave Kramer and Antoline. So they are aware that we are interested in a space to help us store things and for cheer practice space. If they do decide on a space they would sell we should be in a good place to acquire it.

5. New Business

- a. Volunteer discussion: Anyone wanting to volunteer to Coach Cheer or Football can register on the website as they register their participant. Cheer coaches who haven't signed up but are still interested can talk to Ashley. Football coaches please register and the head coaches will reach out once they see who has all signed up and made their decisions. Someone will reach out to you if you even if do not get selected to coach to see if you are interested in helping in any other way. All coaches must have volunteer clearances. First year coaches must fill out the coaching application. We also have a number of committees that help us get through the season. They include Fundraising, Homecoming Program, Community Service, Spirit, Banquet, Concession stand and Grounds. As volunteers are needed we will send out sign ups electronically. If you know you are interested in anything in particular now you can see Jenn or Jenny and give them your info and we will get ahold of you. They are working out a system to where volunteers will get their check/cash back as soon as they complete their hours.
- b. Audit/Trustee report (maybe): We have never done an audit that Kayla has seen. We were quoted \$25,000 for an actual audit. We did an internal audit instead. Kayla, Jenn and Bill were audit trustees. We got through most of 2022. Kayla still has August to get through and 2021. So far we haven't seen anything too crazy. No blatant wrongdoing noticed. Some things made us adjust the way we handle finances in our bylaws. If you have budget for a particular thing that doesn't mean you have to spend it. How many organizational debit cards are issued was cut. Nothing alarming. Kayla will have full report for next meeting.

c. By-laws:

Kayla: The Executive Board has been working collectively as a group to revise our Bylaws since February and it's something I've personally wanted to tackle for about 3 years now. I'm very proud to announce that this morning, the Executive Board voted to pass the

revised By-Laws. 12 out of 13 members voted with a vote of 12-0. I feel like these revised by-laws fix mistakes found in the old ones & help cover situations that were maybe not thought of during the writing of the original ones. They also put in to writing rules that we've gone by but didn't have written down. Helps protect the kids & organization.

- 1. Page 1 Article II define "General Board" as anyone who has their 6 meetings and when they vote vs. the Executive Board
- 2. Page 3, Article 4 (IV), Section 2 (A) Terms for all officers, HOF & HOC, and all executive board members are now 1 year. Previously all were one year except for HOF & HOC which were 3 years.
- 3. Page 3, Article 4 (IV), Section 2 (B). Now allows for electronic nominations in addition to nominations at both October meetings & the November meeting. Nominations can be made by emailing the President & Secretary due one week prior to the nomination meeting. Electronic nominations will be read at the following meeting. Also adds that any nomination not accepted prior to the end of the November meeting will not be on the election ballot & all acceptances must be in person by the person nominated.
- 4. Page 5, Article 4 (IV), Section 4 cleaned up the previous responsibilities for executive board members & also added expectations.
- 5. Page 8, Article 5 (V), Section 2 added that all head coaches are to be approved by the Executive Board. Added how many maximum coaches each team can have. Added coach applications this is to be used as a tool to help head coaches make informed decisions. Head coaches retain the right to pick their assistants.
- 6. Page 9, Article 5 (V), Section 4 Added how BCYFL representatives are chosen & what's expected of them.
- 7. Page 10, Article 5 (V) Section 6 & 7 added protocol for choosing senior bowl & all star games. 7 added responsibilities of football players & parents
- 8. Section 6 (VI) has most of the same changes as football. Page 12, changed gameday squads to 25.
- 9. Page 14 Article 7 (VII) Sections 1 & 2 added that equipment manager & head of grounds must be executive Board members unless otherwise approved by the executive Board
- 10. Page 15 Article 8 (VIII) changed how many are registered on the checking account & has debit cards. The bylaws & appendix II contradicted themselves prior which lead to 7 being on the bank account. Added a reimbursement form. In section 2 spelled out how approvals are to be made. Having a budget does not exempt getting approval from executive board prior to making purchases. Page 16 (C) purchases not approved by the proper manner can be declined for reimbursement or if paid by debit card, risk being required to repay the organization or being taken off the account. This is due to the recent audit we had. Added if a check is to reimburse an executive board member or made out to cash must have two signatures & no executive board member can write themselves, a family member or member of their household a check.

- 11. Appendix I deleted trial entirely. Never seen one done. If any member of the eboard is deemed to be behaving ...etc in (E), they can be removed with a majority vote. Right to appeal. Added ethics section.
- 12. Appendix II volunteer checks coaches & team parents will be assessed annually based on registration numbers. If required to give a check, it will only be \$100 (regular is 200) for 2 volunteer hours/1 activity. New equipment signout form coming.
