- 3. Committee Reports:
 - a. Football
 - i. BCYFL Report/Updates:
 - 1. General: Last BCYFL meeting was 6/12/23. Jaycen handed in old jerseys for BCYFL picture, team enrollment numbers as of 6/11 & a copy of our insurance.
 - 2. Schedule: Any team playing North Catholic, those games turned to bye weeks unless it was a home game due to the financial impact on organizations and were reschedule without redoing the entire schedule.
