1. Approval of Minutes from last meeting

3. Committee Reports:
 - a. Football
 - i. BCYFL Report/Updates: Had a meeting on 3/10. New board that is governing Aliquippa Lil Quips. Harv no longer involved. Brought 7 figures to the meeting including Dr. Woods & coach Warfield from HS. Trying to give them more credibility. Because they created a new group, petitioning to rejoin the BCYFL. Told everyone to go back to programs – and submit a vote. Organizations voted to NOT let the Lil Quips rejoin the BCYFL. They did get in to another league near Pittsburgh. They are in a 2 year ban currently. There was another large organization who collapsed - Western PA football league. Director stole \$300,000. Southside, West A & Seneca Valley is possibly joining the BCYFL. Maybe this year or next. BCYFL is trying to do more on social media to spin the league in a more positive light. Game of the week – interview the kids & coaches, etc. Proposing to start a 10u & 12u allstar travel teams. Details still being put together. Currently a court case with the old Quip organization – Harv is still fighting that battle. Lawyers from BCYFL say that probably means nothing but if that continues – we may need to help with court costs. Next court date beginning of April. Organizations will be held to a lot stricter sideline rules – press passes (camera people), coaches, parents (cheer & football) will need to be carded.

All summer practices will be at the Middle School. Eddie – check in to Penn State for practice location.
